Coastal Cruisers Bicycle Club membership is on a calendar year basis, running from Jan. 1 to Dec. 31 of each year. Dues are \$15 per year for a single member (\$7.50 if a student), or \$20 per year for a family (immediate). Full dues are required for those new memberships received through June. Dues for those new memberships received during July thru September are half the normal dues. October through December dues are \$15 single and \$20 for a family - this includes the dues for the following year - a 15 month membership.

IN CONSIDERATION of being permitted to bicycle with the COASTAL CRUISERS BICYCLE CLUB sponsored activities, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1 ---- ACKNOWLEDGE, agree and represent that I understand the nature of bicycling activities and that I am qualified, in good health and in proper physical condition to participate in CCBC activities. I further acknowledge that CCBC activities will be conducted over public roads and facilities open to the public during the activity and upon which the hazards of traveling are to be expected. I warrant that at any time I believe conditions to be unsafe, I will discontinue further participation in the CCBC.

2 ---- UNDERSTAND that; (a) bicycling activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death; (b) these risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the "Releasees" named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time: hence I fully accept and assume all such risks and all responsibilities for losses, costs and damages I incur as a result of my participation in the CCBC activity.

3 ---- HEREBY release, discharge and covenant not to sue CCBC, the League of American Bicyclists, the respective administrators, directors, agents, officers, volunteers, and employees, other participants, sponsors, advertisers, owners and lessors of premises on which the activity takes place (each considered one of the "Releasees herein) from all liability, claims, demands, losses, or damages on my account caused in whole or in part by the negligence of the "Releasees" to include negligent rescue operations; I further agree that if despite this Release and Waiver of Liability, assumption of risk, and indemnity agreement. I, or anyone on my behalf, makes a claim against any of the "Releasees" I will indemnify, save, and hold harmless each of the "Releasees" from any litigation expenses, attorney fees, loss liability, damage, or cost which may occur as a result of such claim.

I HAVE READ THIS AGREEMENT, fully understand the terms, understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance shall continue in full force and effect.
